INTRODUCTION

The Ramakrishna Mission, is a spiritual organization of international repute, having its headquarters at Belur Math, Howrah, West Bengal, India. This was founded by Swami Vivekananda in May 1897 for the propagation of Sri Ramakrishna's spiritual teachings and for the dissemination of the rich cultural heritage of India. Inspired by the ideals of renunciation and service, the monks and lay devotees of the Math and Mission serve millions of men, women and children, without any distinction of class, caste, religion or race, looking upon people as the veritable manifestations of the Divine. Swami Vivekananda's aims and ideals found pithy expression in his utterance '*Atmano Mokshartham Jagaddhitaya Cha*' that he made before the members of the Mission, monastic and lay. Meaning 'for one's own spiritual liberation and for the well-being of the world' this later became the motto of the organization.

The Ramakrishna Mission was registered on 4th May 1909 under the Societies Registration Act (Act XXI of 1860 revised according to the West Bengal Act XXVI of 1961) and its registration no. is S/ 917 of 1909-10. The Mission branches are spread all over India and in many other countries of the world.

As mentioned earlier, the motto of the Ramakrishna Mission is the liberation of the individual self and the well-being of the world. The aim is to practice and preach the *Sanatana Dharma* or the Eternal Religion as embodied in the lives and teachings of Sri Ramakrishna, Sri Maa Sarada Devi and Swami Vivekananda, work as worship, potential divinity of the soul, and harmony of religions are the ideals on which these two organizations are based. It is this ideal of service to man as service to God that sustains the large number of hospitals, dispensaries, mobile medical units, schools, colleges, rural development centres and many other social service institutions run the twin organizations.

In retrospect

A group of people inspired with the ideal of service preached by the great Swami Vivekananda established Sri Ramakrishna Seva Samity, Dibrugarh in the year 1928 with the motive of educating marginalized kids by opening a Night School. This was started in a rented hut situated at the very place where at present the “RANGGHAR CINEMA HALL” stands. Later on in the year 1935, it was relocated to Shantipara Puja Mandap and activities like Charitable Dispensary, Lower Primary School were added.

The celebration of the Birth Centenary of Sri Ramakrishna in the year 1937 was the breakthrough event in the history of Sri Ramakrishna Seva Samity, Dibrugarh. For the first time, this attracted the attention of people, particularly young men to actively participate in its service activities. Those were the days when Small Pox, Cholera & Typhoid epidemics were rampant. Young men organized themselves into groups of volunteers. One group attended the sick and afflicted families whereas the other engaged in the cremation of the unclaimed dead /corpses from the then Medical School Hospital and of destitute families.

In the year 1936, Late Nandeswar Chakraborty a gentleman of Dibrugarh who was known for his benevolence and generosity donated one Bigha of land, at Purnananda Road, Dibrugarh where the present Ramakrishna Mission, Dibrugarh stands. In 1937, the Seva Samity was shifted to the above site and permanently instated there after the construction of a small temple along with two tin-roofed houses. In the year 1942-43 the Seva Samity started a student Home in one of those houses. In-1959 another One *Bigha* of land was donated by Sri Chakraborty towards the north of the plot. In the year 1961, an auditorium was constructed to facilitate meetings and congregations etc., presently known as the “VIVEKANANDA HALL”. In the year 1965, another piece of

land measuring 3 *Kathas* and 2 *Lessas*, adjacent to the present premises was purchased from the successors of Late Nandeswar Chakraborty.

Subsequently, the present temple was constructed to accommodate the increasing number of devotees. It was consecrated by Srimat Swami Gambhiranandaji Maharaj, the then President of Ramakrishna Math and Ramakrishna Mission on 23rd March 1986. In the year 1996 another piece of land to the Southern side of the campus measuring 1-*Katha*, 5 *Lessas* was purchased for extension of the existing charitable Dispensary of the Seva Samity.

The Seva Samity was registered in the year 1954-55 under the Registration of Societies Act. XXI of 1860. This enabled the Samity to systematically organize and manage the gradually increasing activities. "*Vivekananda Yuvak Sangha*" was formed in September '95 as wished by Rev. Swami Gahananandaji Maharaj, the then Vice-President of Ramakrishna Math and Ramakrishna Mission. This youth wing was responsible for the activities like Celebration the National Youth Day, Saraswati Puja, Free medical camps in remote villages, Book sales, Library, Relief during natural calamities and *AnnaKhetra* for poor people. The *Anna khetra* distributes cooked food every last Sunday of the month as a regular practice since January 1997 (12-1-97). Yoga classes and Art class were initiated in the year 1993. "Maa Sarada Kindergarten" for young children was started by the Seva Samity during 2001.

Ramakrishna Seva Samity managed regular spiritual activities like Daily worship in the temple and daily evening *Aratrika* with devotional songs, daily reading from holy books, Ramanam Sankirtan on Ekadashi *tithis*, preaching & propagation of Ramakrishna - Vivekananda ideals at places such as Moran, Mariani, Sonari, Sibsagar, Bhadoi Panchali, Dikom etc. The Samity also organised special celebrations like the birth *tithis* of Sri Ramakrishna Deva, Sri Ma Sarada Devi and Swami Vivekananda as public celebrations. The birth *tithis* of all the sixteen direct disciples of Sri Sri Thakur were also observed. *Jagaddhatri Puja* celebrated with much enthusiasm every year, continues to be a special attraction. Initiation programmes were arranged during the visits of Revered President and Vice President of Ramakrishna Math & Mission.

3 to 5 day long Annual Celebrations witness various programmes, such as special puja of Sri Sri Thakur, *Chandipath*, *Kirtana*, *Bhakta Sammelan*, competitions on drawings, songs, sports, quiz & essay writing, in Assamese, Bengali, English & Hindi languages. The celebrations also

include *Bargeet*, *Satriya* Dance, Dance-drama on the lives of Sri Sri Thakur, Sri Sri Maa and Swamiji etc.

The Annual conference of “*Uttar Purbanchal Ramakrishna Vivekananda Bhav Prachar Parishad*” was held at the Seva Samity premises for the year 1988, 2001 and in 2010. Since its inception in the year 1928, a number of monastic dignitaries including the Presidents, the Vice Presidents of Ramakrishna Math & Ramakrishna Mission have sanctified this *Ashrama* by their holy visits. Meetings, discourses etc. were held during such visits. It is also worthwhile to mention that apart from the monastic dignitaries, many distinguished persons and luminaries including the Father of the nation, Mahatma Gandhi and the Chief Justice of Calcutta High Court have graced the premises of this – a rare privilege and honour.

PRESENT POSITION AND ACTIVITIES

It is evident that since the year 1928, the Ramakrishna Seva Samity has been marching on, towards its goal of achieving its objectives of promoting the spirit of love, selfless service & sacrifice for the suffering humanity. The Seva Samity pledges its commitment to develop goodwill amongst people and help them to mould their lives according to the Life and Teachings of Sri Ramakrishna, Sri Sarada Devi and Swami Vivekananda. **Finally, at the earnest request of the Managing Committee of the Seva Samity and with due approval of the Governing Body of Ramakrishna Math and Ramakrishna Mission, Belur Math Sri Ramakrishna Seva Samity, Dibrugarh with all its moveable and immoveable property was taken into the folds and under the aegis of the Ramakrishna Order on 18th February 2018.** It is functioning at present with the new name of Ramakrishna Mission, Dibrugarh, Assam ever since. The threat of COVID-19 pandemic couldn't abate the enthusiasm of the monastics and devotees or deter them from serving the society with dedication and rendering selflessness services despite all odds. The Ramakrishna Mission, Dibrugarh has significantly expanded since its inception and currently functions under the following major areas:

MEDICAL SERVICES:

- Weekly Charitable Dispensary is a small initiative taken long back in the year 1935. Under this Dispensary poor people with chronic diseases that need continuous and sustained medication are aided. Our specialized areas are:
 - Diabetics
 - Cardiac
 - Thyroid
 - Hyper Stress and Hyper Tension
- Ramakrishna Mission Charitable Dispensary regularly

identifies patients suffering from these diseases who are unable to bear the regular expenses in the form of medication and related pathological tests. General patients are also taken care of. This year we have treated a total of 843 cases and 6 pathological camps for all the 843 patients were organised. Following camps were organised periodically in the dispensary:

- Diabetes detection/screening test
- Thyroid function test
- Liver function test
- Lipid profile test

EDUCATIONAL SERVICES:

- **Maa Sarada Kindergarten:** Year 2001 marks another prominent initiative in the form of opening of **Maa Sarada Kindergarten**. The objective of this service activity is to impart moral values and Indian culture-based education, during the formative life of children in close association with the parents. During this academic calendar 56 children are being nurtured with the help of 4 teachers and 2 supporting staffs. During the pandemic scenario Maa Sarada Kindergarten, one of the mainstays of our activities was running in online mode. Now it has resumed its original mode of operation and class are being conducted in the morning session from 9.30 am to 12.30 pm Monday to Friday.
- **Daily Yoga Class:** Since year 1993 “Vivekananda Yoga Centre”, is conducting daily Yoga classes in the Ashrama premises to help devotees and general public to improve their holistic health parameters and resolve health issues. It is believed that a healthy body is the first requisite in the path of Spiritual emancipation. This daily programme is organised at Vivekananda Hall under the able guidance and support of trained and certified Yoga Instructors on week days. Despite its increasing demand, the paucity of space and supporting infrastructure restricts us to serve on an average only 25 participants in one class.
- **Vivekananda Youth Forum:** Our nation celebrates National Youth Day on the birthday of Swami Vivekananda with a view to disseminate his philosophy to our contemporary generation of youth and inspire as well as motivate them with the practiced ideals of Swamiji, veritably our national Youth Icon.”My faith is in the younger generation, the modern generation, out of them will come

my workers!” said Swamiji. To infuse the ideas and ideals of Swamiji among the youth so that they become worthy citizen of our Mother Land, Ramakrishna Mission, Dibrugarh had started “Vivekananda Youth Forum” for young men of age group 18 to 35 years in the Ashrama premises. We have started this youth programme from the month of July, 2021. The programme is conducted weekly on every Sunday from 8.00 am to 9.30 am. On an average 8-10 participants take part in this programme.

- **Celebration of National Youth Day & Azadi Ka Amrit Mahotsav:** It is known that this year marks the 75th anniversary of the Independence of India. The Government of India had named this yearlong celebration as “**Azadi Ka Amrit Mahotsav**”. On the special request of the Ministry of Culture, Govt. of India, Ramakrishna Mission at Headquarters and through all the branch centers had decided to celebrate the occasion on a grand scale through different programmes. As the **1st Phase of Celebration** we at Ramakrishna Mission, Dibrugarh organised different school level competitions on 11th January 2021 for students of Secondary and Higher Secondary Schools. In these events in all 34 students from 10 different schools took part and prizes were distributed on the Youth Convention organized on 12th January 2021, a two-day event of celebration.
- **Dibrugarh Book Fair:** To promote Ramakrishna-Vivekananda-Vedanta literature and literature on Religion, Culture, Art and Self-Development among the residents of Dibrugarh and nearby townships, we participated in the Dibrugarh Book Fair organized during 26th November to 7th December 2021. Due to shortage of needed stock of literature we couldn't have expected sales but we were successful in registering our presence among the reading enthusiasts with this participation.

WELFARE SERVICES:

- **Monthly monetary and daily provision help to poor widows:** Unlike previous years, we are continuing with the activity “Poor Widow Welfare Service”; monthly monetary and daily provision support to 20 poor and old widow mothers. Widow mothers collect the support items on the first Sunday of every month so that they could manage the monthly affairs with ease. We have served them with financial help of `1,000/- (Rupees one Thousand only) in cash

and a bag of dry ration worth ` 500/- (Rs. Five Hundred only). These twenty widow mothers were short listed at the very outset of the financial year on the basis of our pre-decided norms.

- **Scholarship to poor, meritorious students: "Vivekananda Scholarship"** is one of the core service activities of Ramakrishna Mission, Dibrugarh. This was initiated in the education calendar year 2019-20. Consistency of the policies and service activities is one of the pillars on which Ramakrishna Order is grounded. In tandem with this strategy, the one-time scholarship was awarded to 20 poor but meritorious students from 10 Secondary and Higher Secondary Schools of Dibrugarh city for the education calendar year 2020-21. A bank cheque of INR 5,000/- (Rupees five Thousand only) in the name of one of the parents or guardians was handed over to each student. This was done on 12th January, 2022 in the function organized to celebrate National Youth Day.
- **Weekly Annadanam: "Sarada Annakhetra"**, in keeping with the spirit of *Daridra Narayana Bhava* (God in the form of Poor and Needy) Ramakrishna Mission, Dibrugarh serves cooked food at noontime to 50-60 poor people every Sunday. This too is a consistent service activity we are maintaining since the Sri Ramakrishna Seva Samity, Dibrugarh was taken into the folds of the Ramakrishna Order on 18th February 2018. That a few of our young devotees and volunteers shoulder the entire responsibility of fundraising, cooking and serving the meals makes this a very special effort.
- **Distribution of Blankets and Clothes under Winter and Distress Relief:** New and good quality Blanket, Sari and Lungi; 500 pieces of each of the items, directly procured from Ludhiana, Punjab and other places are being distributed among the 500 poor and needy families of Dibrugarh city and near about villages. New articles of clothing for men, women and children received from ITC company were distributed among the poor and needy people of remote villages. 8 slums of Dibrugarh city and 4 remote villages around Dibrugarh district are the beneficiaries of these relief items. These relief activities took place during the month of December-21 to January-22. Entire relief work was organized under the direct supervision of monk in-charge and devotee volunteers and it takes

months together as a preparation and distribution of the items to ensure deserving candidate and family.

- **Covid-19 Relief work:** The world was reeling under the devastating effects of **Second Wave of Corona Virus** (Covid-19) pandemic. As we all know our country too imposed long durations of Lockdown in different phases to curb the spread of the disease during the second wave. Consequently, poor people, especially the daily laborers had to bear the brunt of loss of livelihood options. In this situation of unprecedented of humanity, following the tradition of Ramakrishna Order, Dibrugarh center came forward to mitigate their suffering to some extent by conducting Relief work specially among the poor Daily Wage Earners in some of the slums of the Dibrugarh city under the guidance of the Headquarters. The Second Phase Covid-19 Relief work was the chief initiative that the *Ashrama* took during this time. 27th May to 9th June 2021 was the time period within which Relief work was undertaken. Details of the Relief Activity are listed as follows:

- **Primary Relief Work:** River Jiahal had flooded 22 adjacent villages situated in and around Dhemaji township of Assam due to continuous heavy rainfall in the region for 17 days. Though we couldn't take up the Relief work during days of severe floods but could address the considerably the devastating aftermath of flood-affected areas which was colossal in terms of material and financial losses incurred by the villagers. We could take up Primary Relief Work in 15 flood affected villages only. Initially there was some sort of resistance and negativity from DC Office, Dhemaji but due intervention of Sri Pallav Gopal Jha, IAS, DC Dibrugarh and Dr. Baluram Mili we could undertake the Relief work smoothly and brought to aculmination on 10th September 2021. Our Relief

SPIRITUAL AND CULTURAL SERVICES:

- Ramakrishna Mission, Dibrugarh is fortunate to house a beautiful universal Shrine dedicated to modern Incarnation Sri Ramakrishna Deva. The Temple acts as a pivot in organizing the following Spiritual and Cultural services for the votaries of Ramakrishna Order as well as general public:

The Ashrama, as part of its regular religious and spiritual activities, conducts formal *Nitya Puja* (daily worship) and *Sandhya Arati* (daily evening prayers) in the quiet atmosphere of the Shrine in which monks, Brahmacharis and the devotees participate. Apart from *Tithipujas* of Sri Ramakrishna, Holy Mother Sarada Devi, and Swami Vivekananda, birthdays of monastic disciples of Sri Ramakrishna are celebrated round the year. The Ashrama also celebrates the Buddha Purnima, Christmas Eve, and Pujas such as Saraswati Puja, Kali Puja, Shiva Ratri, Janmashtami, Ramnavami and Jagaddhatri Puja which are also performed duly. The Jagaddhatri Puja, in particular, is one of the major concerns of the Ashrama and it is celebrated through a day-long programme with all the solemnities. Local people and devotees come forward with generous donations in cash and also provide items necessary for the celebration.

Besides such formal worship and celebrations, the Ashrama also conducts scriptural classes to provide spiritual thoughts to the

aspirants. It also arranges *Bhakta Sammelan* and *diksha* for the benefit of the local spiritual aspirants from time to time. During the entire year, a total number of weekly and other classes held in the Centre are 182 and approx. a total number of 3640 devotees were present. In the 15 different celebrations which were organized during the year an approx. 6360 devotees remained present.

- **Mahasamadhi of Rev. Swami Shivamayananda Ji Maharaj:** Rev. Swami Shivamayananda Ji Maharaj, Vice-President, Ramakrishna Math and Ramakrishna Mission, Belur Math, Howrah attained mahasamadhi on 11th June 2021. It was a very sad news for Devotees of Dibrugarh specially as he had been closely connected with the devotees of this place and initiated near about 700 devotees with *mantra diksha*. On 23rd June 2021 a memorial meeting with special worship was conducted at the Temple in which about 70 devotees visited the Ashrama in person, following COVID-19 SOPs and received fruit *prasad*. The entire programme was broadcasted real time via Dibrugarh 24X7 channel.
- **Celebration of Sri Sri Jagaddhatri Puja:** Ramakrishna Mission, Dibrugarh is fortunate enough to be able to offer every year special *Puja* to the Divine Mother Shri Shri Jagaddhatri on a grand scale for the people of Dibrugarh city. In this connection it may be noted that Sri Sri Jagaddhatri Puja of RKM, Dibrugarh may be the only public puja offered to the Divine Mother in Dibrugarh city. This year as per the Vishuddha Siddhanta Almanac puja was offered from 11th Nov to 13th Nov 21. On 12th Nov. we offered *Saptami*, *Ashtami*, and *Navami Puja* in three *paharas*. Navami Puja was concluded with *Homa* at 4.30 pm. *Dshami Puja* and *Visarjana* took place on 13th Nov. 2021. The auspicious sprinkling of *Shanti Jal* took place after the evening prayer of Sri Sri Thakur. *Khichuri prasad* and fruit & Sweet prasad were distributed to 3,000 devotees. COVID-19 SOPs were diligently followed by the assembled devotees during these days.

SUPPORTING SERVICE ACTIVITIES:

Launching of Website for Ramakrishna Mission, Dibrugarh: Rev. Swami Achyuteshananda Ji Maharaj, Secretary, Ramakrishna Mission, Narottam Nagar, AP launched the first ever website of Ramakrishna Mission, Dibrugarh on the auspicious day of **Ratha Yatra, 12th July 2021**. On the occasion, the website hosted a written message of Blessing from

Most Rev. President Maharaj, Ramakrishna Math and Ramakrishna Mission, Belur Math and short video message from Rev. General Secretary Maharaj on the occasion. We hope this small but important gesture of the Ashrama will help devotees and general public to access pertinent information during this nascent period of digitalization of our country-wide website. Our website url is: www.rkmdibrugarh.org.

- **Renovation work:** The Ashrama was in need of a place to conduct official affairs and a space where devotees and visitors could congregate. To resolve this requirement, we undertook the renovation and restoration work of the Old Temple block and could complete construction within stipulated time frame. At present, the renovated block houses the day to day office activities. 25 trucks of garden soil is being procured to fill the area surrounding the temple to protect it from water logging during rainy days. Painting and whitewashing work in Vivekananda Hall, General Bhandar and Temple has already been completed.
- **Installation of 25kv silent Generator Set:** Electric load shedding is a perennial problem in Dibrugarh city which becomes acute during summer months. In keeping with latest norms in cities like Dibrugarh, we have procured a 25 kv silent Generator Set of Mahindra brand and has been commissioned in the month of November 2021 replacing the noisy older one of 5kv.

RAMAKRISHNA MISSION, DIBRUGARH ON MARCH.....

- Spiritual activities like daily worship of Holy Trio, *Nat mandir for Bhajan-Kirtan, Japan-Dhyana*, regular scriptural classes were being carried out even with moderate infrastructure.
- However, to carry out the Service activities the present infrastructure is inadequate. In addition, necessary building to provide lodging for Monks, helping Staff and devotees are the immediate requirements of infrastructural improvement. Hence immediate construction of Monks Quarters, Staff Quarters, Guest Houses, Kitchen cum Dining Hall and an Administrative Block seems unavoidable.

Also, the available property at the present location compels us to think of a second and a bigger plot of land to extend service activities by creating suitable Medical, Educational and Cultural infrastructure.

Independent Auditor's Report

**EXTRACTS FROM THE MEMORANDUM OF ASSOCIATION OF THE
RAMAKRISHNA MISSION**

**REGISTERED ON THE 4TH MAY, 1909, UNDER ACT XXI OF 1860,
REGISTRARION NO. SO916370 (Legacy Reg. No: 1917/3) OF 1909-**

10. REVISED ACCORDING TO WEST BENGAL ACT XXVI OF 1961.

1. a) The name of the Association is THE RAMAKRISHNA MISSION.
It may also be spelled as RAMAKRISHNA MISSION.
2. The objectives of the Association are:
 - a. To impart and promote the study of the Vedanta and its principles as propounded by Sri Ramakrishna and practically illustrated by his own life and of Comparative Theology in its widest form.
 - b. i) To impart, promote and undertake the study of and research in the arts/humanities, sciences, technologies and industries in all their branches both basic and applied.
ii) To undertake scientific research in the area of medical sciences.
 - c. To train teachers in all branches of knowledge above-mentioned and enable them to reach the masses.
 - d. To carry on educational work among the masses.
 - e. To establish, maintain, carry on and assist schools, colleges, universities, research institutions, libraries, auditoriums, orphanages, workshops, laboratories, hospitals, dispensaries, houses for the aged, the infirm, the invalid and the afflicted, relief and rehabilitation works, and any other educational, medical cultural and social welfare service activities and training institutions and charitable works and institutions of a like nature.
 - f. To take up development and general welfare activities for the benefit of the underprivileged / backward / tribal people of the society without any discrimination.
 - g. To print and publish and to sell or distribute, gratuitously or otherwise, journals, periodicals, books or leaflets that the Association may think desirable for the promotion of its objects.
 - h. To carry on any other work which may seem to the Association capable of being conveniently carried on in connection with and calculated directly or indirectly to promote any of the before-mentioned objects.

Pressing Issue of Ramakrishna Mission, Dibrugarh:

- Existing buildings being very old, we have undertaken much-needed repair and renovation work.

A HUMBLE APPEAL TO THE DEVOTEES :

Following the path shown by Swami Vivekananda, *the work of* Ramakrishna Mission depends equally on monks and lay devotees. To implement the ideal “*for the liberation of the soul and service to the world*” in the system of organisation we broadly execute two sets of activities. One set of activities are temple oriented e.g. *Puja, Japam, Dhyana, Utsav, Bhakta Sammelan* etc. and the second are service-oriented e.g. helping society through different service activities; Medical, Educational and Cultural.

The spiritual activities like daily worship of Holy Trio, *Nat mandir for Bhajan-Kirtan, Japan-Dhyana*, regular scriptural class and special programmes on special occasions could be carried out even with limited infrastructure. But to carry out the Service activities the present infrastructure is strikingly inadequate. Again, necessary building to provide lodging for Monks, Helping Staff and Devotes is an urgent requirement. Hence immediate construction of Monks Quarters, Staff Quarters, Guest Houses, Kitchen cum Dining Hall and an Administrative Block seems unavoidable. Such constraints pose as hurdles in the smooth conduct of all the activities.

“The wavy waters in the picture are symbolic of Karma; the lotus, of Bhakti; and the rising-sun, of Jnana. The encircling serpent is indicative of Yoga and awakened Kundalini Shakti, while the swan in the picture stands for the Paramatman (Supreme Self). Therefore the idea of the picture is that by the union of Karma, Jnana, Bhakti and Yoga, the vision of the Paramatman is obtained.”
